IN 2024-2025 AIGA IS IN ITS THIRD SEASON OF THE CHAMPIONS LEAGUE, BRINGING TOGETHER THE BEST TEAMS FROM AROUND THE WORLD TO COMPETE FOR THE GRAND PRIZE. IN 2024, THERE WILL BE QUALIFIERS FOR THE GROUP STAGE OF THE AIGA CHAMPIONS LEAGUE, AS A RESULT OF WHICH THE TOP 8 TEAMS WILL COMPETE IN THE CHAMPIONS LEAGUE.

BASED ON THE RESULTS OF THE SELECTION IN TURKIYE, ONE TEAM WILL ADVANCE TO THE GROUP STAGE;

BASED ON THE RESULTS OF THE SELECTION IN BRAZIL, ONE TEAM WILL ADVANCE TO THE GROUP STAGE;

BASED ON THE RESULTS OF THE QUALIFICATION IN THE UNITED STATES OF AMERICA, TWO TEAMS WILL ADVANCE TO THE GROUP STAGE;

ACCORDING TO THE RESULTS OF THE QUALIFICATION IN THAILAND, ONE TEAM WILL ADVANCE TO THE GROUP STAGE.

THE CHAMPIONS OF THE SECOND SEASON ADVANCE
TO THE GROUP STAGE OF THE CHAMPIONS LEAGUE WITHOUT QUALIFYING;

THE ORGANIZERS RESERVE THE RIGHT TO INVITE TEAMS TO THE GROUP STAGE UNTIL THEIR NUMBER REACHES SEVEN.



IF MORE THAN FOUR TEAMS PARTICIPATE IN THE QUALIFIERS, A BRACKET WILL BE DRAWN UP AND ONLY THE WINNING TEAM WILL ADVANCE TO THE NEXT ROUND.

IF THERE ARE FEWER THAN FOUR TEAMS IN THE QUALIFIERS, EACH TEAM WILL HAVE TO COMPETE AGAINST EACH OTHER. THE TEAM WITH THE MOST POINTS WILL BE DECLARED THE WINNER AND ADVANCE TO THE GROUP STAGE OF THE CHAMPIONS LEAGUE.

ONE TEAM IS ELIGIBLE TO QUALIFY ONLY ONCE.



MAY 2025 KAZAKHSTAN (FIRST QUARTER-FINAL)

EACH TEAM WILL HAVE TO COMPETE AGAINST EACH OTHER. THE TWO TEAMS WITH THE MOST POINTS WILL ADVANCE TO THE SEMI-FINALS OF THE CHAMPIONS LEAGUE.

JULY 2025 KAZAKHSTAN (SECOND QUARTER-FINAL)

EACH TEAM WILL HAVE TO COMPETE AGAINST EACH OTHER. THE TWO TEAMS WITH THE MOST POINTS WILL ADVANCE TO THE SEMI-FINALS OF THE CHAMPIONS LEAGUE.

SEPTEMBER 2025 KAZAKHSTAN (SEMI-FINALS AND FINAL)

IN THE EVENT THAT ONE OF THE QUALIFIED TEAMS WITHDRAWS FROM THE CHAMPIONS LEAGUE, AFTER SIGNING THE CONTRACT, IT WILL HAVE TO RESPOND IN ACCORDANCE WITH THE PROVISIONS OF THE CONTRACT. INSTEAD, THE ORGANIZERS HAVE THE RIGHT TO CHOOSE ANOTHER TEAM.

IN THE EVENT THAT ONE OF THE TEAMS THAT HAVE QUALIFIED FOR THE SEMI-FINALS WITHDRAWS FROM THE CHAMPIONS LEAGUE, IT WILL HAVE TO RESPOND IN ACCORDANCE WITH THE CONTRACT AND THE TEAM OF THE SAME GROUP WITH THE HIGHEST NUMBER OF POINTS WILL BE SELECTED INSTEAD.

THE ORGANIZERS HAVE THE RIGHT TO MAKE ADJUSTMENTS AND AMENDMENTS TO THE REGULATIONS THROUGHOUT THE AIGA CHAMPIONS LEAGUE SEASON.



TEAM MANAGER
TEAM CAPTAIN
ATHLETES

A TEAM MANAGER

IS A PERSON RESPONSIBLE FOR ASSEMBLING A TEAM, PROVIDING FINANCIAL SUPPORT FOR THE TEAM (ATTRACTING SPONSORS, PAYING FEES, PLANNING AND IMPLEMENTING TRIPS TO THE TOURNAMENT, ETC.), SUBMITTING AN APPLICATION FOR THE CHAMPIONS LEAGUE, RUN NEGOTIATIONS AND AGREEING A CONTRACT WITH THE LEAGUE. AN ATHLETE COMPETING IN THE CHAMPIONS LEAGUE CANNOT BE A MANAGER.

THE TEAM CAPTAIN

IS A PERSON WHO REPRESENTS THE TEAM DURING THE TOURNAMENT, PARTICIPATES IN THE DRAW, REPRESENTS THE TEAM DURING THE TEAM MEETINGS.

ATHLETES

ARE THE ATHLETES WHO COMPETE IN THE CHAMPIONS LEAGUE AS PART OF CERTAIN TEAMS.

THE MINIMUM TEAM SIZE IS 7 PEOPLE, WITH 1 ATHLETE FOR EACH WEIGHT CATEGORY. EACH TEAM CAN HAVE A SUBSTITUTE IN EACH WEIGHT CLASS. ATHLETES HAVE THE RIGHT TO WRESTLE IN THEIR DECLARED WEIGHT CATEGORY OR REPLACE ATHLETES OF A HEAVIER WEIGHT CATEGORY.



THE FINAL TEAM COMPOSITION, WHICH WILL COMPETE, IS APPROVED THE DAY BEFORE ENTERING THE MAT (7 ATHLETES), BUT THE FULL TEAM COMPOSITION MUST BE INDICATED IN THE APPLICATION (I.E. THE APPLICATION MUST INDICATE THE ATHLETES WHO WILL BE REPLACED).

WEIGHT CATEGORIES:

MEN/ADULTS

- 60 KG - 65 KG - 70 KG - 76 KG

- 83 KG - 91 KG + 91 KG



APPLICATIONS FOR THE AIGA CHAMPIONS LEAGUE QUALIFIERS WILL ONLY BE ACCEPTED FROM THE TEAM MANAGER. IT IS NECESSARY TO MAIL TO: AIGAGLOBALOFFICIAL@GMAIL.COM, AFTER WHICH INSTRUCTIONS FOR FURTHER STEPS WILL BE SENT.

THE TEAM MUST CONSIST OF AT LEAST 7 PEOPLE, ONE ATHLETE FOR EACH WEIGHT CATEGORY. THE TEAM CAN INCLUDE REPRESENTATIVES OF ANY COUNTRIES AND CLUBS. IF AN ATHLETE HAS BEEN OFFICIALLY DECLARED IN A TEAM THAT HAS BEEN DEFEATED AT ANY STAGE, HE CAN NOT COMPETE FOR ANOTHER TEAM UNTIL THE END OF THE CURRENT SEASON OF THE YEAR (EVEN IF HE DID NOT COMPETE ON THE MAT). ONLY FROM THE BEGINNING OF THE NEXT SEASON, THE ATHLETE HAS THE RIGHT TO COMPETE FOR ANOTHER TEAM OR REMAIN IN THE SAME TEAM AND CONTINUE TO COMPETE IN THE CHAMPIONS LEAGUE.

THE DURATION OF THE BOUT IS 3 ROUNDS OF 5 MINUTES EACH. FOR THE FIRST TWO MINUTES OF THE ROUND, NO POINTS ARE COUNTED, EXCEPT FOR TAKEDOWN AND MINUS POINTS. AT THE BEGINNING OF EACH ROUND, THE SCOREBOARD IS RESET. THE ATHLETE WHO WINS THE MOST ROUNDS WILL BE DECLARED THE WINNER. IF AN ATHLETE WINS ONE OF THE THREE ROUNDS AND THERE IS A TIE IN THE OTHER TWO, THE WINNER WILL BE AWARDED TO THE ATHLETE WHO WON ONE OF THE ROUNDS. AN EARLY VICTORY IN THE MATCH CAN BE ACHIEVED BY SURRENDERING THE OPPONENT, DUE TO INJURY OR DISQUALIFICATION.

IN CASE OF AN EARLY VICTORY OF ONE OF THE TEAMS, THE ATHLETES WHO DID NOT HOLD THE MATCHES ARE OBLIGED TO COMPLETE THEIR MATCHS.

ALL PARTICIPANTS OF AIGA GRAPPLING COMPETITIONS ARE OBLIGED TO:

- STRICTLY FOLLOW THE RULES;
- · COMPLY WITH THE REQUIREMENTS OF JUDGES;
- BE POLITE TO ALL PARTICIPANTS OF THE COMPETITION:
 REFEREES, ORGANIZERS, TO YOUR OPPONENT, AS WELL AS TO THE AUDIENCE;
- ADHERE TO THE RULES OF SPORTS AND FAIR COMPETITION;
- A PARTICIPANT OF THE TOURNAMENT, UNDER NO CIRCUMSTANCES MUST INTENTIONALLY HARM THE HEALTH OF THE OPPONENT;
- BE NEAT, HAVE CLEAN SPORTS EQUIPMENT APPROVED BY THE ASSOCIATION, PERFORM WITH SHORT-CUT FINGERNAILS AND TOENAILS.



TECHNICAL ACTIONS AND POSITIONS EVALUATED

IF YOU CHANGE MULTIPLE POSITIONS, POINTS WILL BE AWARDED ONLY FOR THE POSITION THAT IS HELD FOR 3 SECONDS OR MORE.

POINTS FOR EACH POSITION ARE AWARDED WHEN IT IS FIXED FOR AT LEAST 3 SECONDS, PROVIDED THAT THE ATTACKING ATHLETE IS NOT TAKEN BY THE OPPONENT FOR A PAINFUL OR CHOKE HOLD.

IF AN ATTACKING ATHLETE IS TAKEN BY SUBMISSION OR CHOKE, IN ORDER TO GET POINTS FOR A TECHNICAL ACTION OR POSITION, HE MUST FREE HIMSELF FROM THE THREAT OF A PAINFUL HOLD AND HOLD THE OPPONENT FOR 3 SECONDS.

PERMITTED TECHNICAL ACTIONS:

- ANY TYPE OF CHOKES (EXCEPT FOR THOSE WHERE THE TRACHEA IS AFFECTED WITH THE HELP OF HANDS);
- ANY JOINTLOCKS ON ELBOW, SHOULDER AND WRIST;
- · ANY LEGLOCKS.



LIGHT PROHIBITED ACTIONS

LIGHT PROHIBITED ACTIONS ARE PUNISHED WITH NEGATIVE POINTS.
THE FOLLOWING ACTIONS ARE CONSIDERED LIGHT PROHIBITED ACTIONS:

- ▶ PASSIVITY OR WITHDRAWAL FROM THE FIGHT:
- * IF THE REFEREE NOTICES THAT ONE OR BOTH COMPETITORS ARE NOT TRYING TO SUCCEED IN THE FIGHT BY STANDING FOR 20 SECONDS, THE REFEREE STOPS THE FIGHT, AWARDS A PENALTY TO ONE OR BOTH PARTICIPANTS, AND GIVES THE COMMAND "FIGHT";
- * IF A COMPETITOR WITHDRAWS FROM THE FIGHT AND STEPS BACK, AVOIDING THE BOUT, HE WILL BE WARNED BY THE REFEREE ON THE MAT, IN CASE OF A REPEATED REMARK HE WILL BE PUNISHED WITH A MINUS POINT (-1);
- * IF A COMPETITOR ESCAPES FROM THE GRIP OF AN OPPONENT WHO HAS APPLIED A PULL-IN BUT DOES NOT TRY TO ENTER THE FIGHT, HE WILL BE WARNED BY THE REFEREE ON THE MAT, IN CASE OF A REPEATED REMARK HE WILL BE PUNISHED WITH A MINUS POINT (-1);
- * AN ATHLETE WHO IS PASSIVE IN A FIGHT WILL BE WARNED WITH THE WORDS "ACTION" AND A TIME COUNT OF 20 SECONDS WILL BEGIN. IF THE ATHLETE DOES NOT CHANGE HIS POSITION OR IS NOT ACTIVE WITHIN 20 SECONDS, HE WILL BE PUNISHED WITH A MINUS POINT (-1);
 - * PASSIVITY OR PROCRASTINATION REFERS TO THE REFUSAL TO PURSUE THE GOAL OF PROGRESSING DURING THE COURSE OF THE ENCOUNTER AND DETERRING THE OPPONENT FROM HIS PROGRESS. PARTICIPANTS WHO DEFEND THEMSELVES FROM PAIN WILL NOT BE PENALIZED FOR PASSIVITY.
- ► IF THE ATHLETE, AVOIDING THE FIGHT, GOES BEYOND THE MAT AREA OR PUSHES THE OPPONENT OUT OF THE WRESTLING ZONE WITHOUT PERFORMING TECHNICAL ACTIONS, HE WILL BE WARNED, IN CASE OF A REPEATED REPRIMAND, HE WILL BE PUNISHED WITH A MINUS POINT (-1);
- ▶ IF THE LIFTER, TRYING TO FREE HIMSELF FROM THE PAINFUL HOLD, GOES OUT OF THE WRESTLING AREA MORE THAN ONCE, HE WILL BE PUNISHED WITH A MINUS POINT (-1), IN CASE OF INTENTIONALLY GOING BEYOND THE MAT DURING THE PAINFUL HOLD, THE ATHLETE WILL BE DISQUALIFIED;
- ▶ PUSH OR PUSH YOUR HAND OR FOOT INTO YOUR OPPONENT'S FACE.
- ▶ IF THE PARTICIPANT GRABS HIMSELF OR HIS OPPONENT BY THE FORM IN ANY WAY;
- ▶ DELAY THE FIGHT DUE TO LACK OF PREPARATION OR FREQUENT AND LONG IMPROVEMENT OF FORM.
- ▶ WHEN AN ATHLETE INTENTIONALLY MOVES TO A GUARD DEFENSIVE POSITION OR MOVES FROM A STANDING POSITION TO A SITTING OR LYING POSITION IN ANY WAY AND STAYS FOR 3 SECONDS OR MORE, HE WILL BE PENALIZED WITH A MINUS POINT (THIS APPLIES ONLY TO THE SECOND PERIOD OF TIME WHEN POINTS ARE AWARDED, IN THE FIRST PERIOD OF TIME THE LIFTER WILL BE PENALIZED WITH A MINUS POINT, IF ONLY HE MOVES TO THE DEFENSIVE POSITION WITHOUT TACKLING THE OPPONENT);

*IF BOTH ATHLETES ARE STANDING AND ONE OF THEM LOWERS ONE OR BOTH KNEES TO THE MAT FOR MORE THAN 3 SECONDS, HE WILL BE PENALIZED WITH A MINUS POINT (-1).

- ► TALKING, COMMENTING, OR EXCHANGING GESTURES WITH SOMEONE IS PUNISHABLE BY A MINUS SCORE (DOES NOT APPLY TO CASES OF REQUESTING MEDICAL ASSISTANCE);
- ▶ IGNORING THE REFEREE'S COMMANDS:
- PENALTIES MAY BE IMPOSED FROM THE BEGINNING OF THE FIGHT;
- ► AFTER THE FIRST NEGATIVE SCORE, VERBAL WARNINGS ARE NO LONGER ISSUED, BUT THE NEXT NEGATIVE SCORE IS IMMEDIATELY GIVEN;
- ► IF AN ATHLETE RECEIVES A MINUS SCORE (-1), THE REFEREE MUST NOTIFY HIM OR HIS COACH.



ROUGH FORBIDDEN TECHNICAL ACTIONS

PUNISHED BY AUTOMATIC DISQUALIFICATION, PARTICIPANTS WHO PERFORM GROSS PROHIBITED ACTIONS THAT ARE NOTICED BY THE JUDGE WILL BE AUTOMATICALLY DISQUALIFIED WITHOUT DISCUSSION

- ▶ "SLAM"
 ▶ "COMPLETE NELSON"
 ▶ "CRUCIFIX"
 ▶ "OPENER"
 ▶ "TWISTER"
 ▶ YOU CAN'T HIT YOUR OPPONENT UPSIDE DOWN ON THE TATAMI MAT WHEN PERFORMING A TAKEDOWN
 ▶ DO NOT ROLL FORWARD WHILE THE OPPONENT IS IN A POSITION BEHIND YOUR BACK;
- ▶ DO NOT MAKE A GUILLOTINE THROUGH THE FACE
- WITH A TWISTING EFFECT ON THE CHIN
- **▶** ANY KIND OF BLOWS
- **▶** ANY IMPACT OF FINGERS IN THE EYES
- **▶** EAR GRABS
- ▶ HAIR GRABS
- ▶ GRIPPING INDIVIDUAL FINGERS (LESS THAN FOUR) OR TOES (LESS THAN FIVE)
- **▶ SCRATCH AND PINCH THE OPPONENT**
- **▶ KICKS**
- **▶** BITES
- ▶ PRESSURE ON THE GROIN AREA
- ▶ IT IS FORBIDDEN TO APPLY SLIPPERY SUBSTANCES TO THE BODY OR CLOTHING



DISCIPLINARY MISCONDUCT

ARE PUNISHABLE BY AUTOMATIC DISQUALIFICATION. ATHLETES WHO, IN THE OPINION OF THE JUDGE, HAVE COMMITTED A DISCIPLINARY GROSS VIOLATION WILL BE AUTOMATICALLY DISQUALIFIED WITHOUT DISCUSSION.

- THE USE OF ABUSIVE LANGUAGE OR INDECENT GESTURES BY THE ATHLETE TOWARDS HIS OPPONENT, THE SECRETARIAT, OFFICIALS, REFEREES OR SPECTATORS BEFORE, DURING OR AFTER THE BOUT;
- ► AN ATHLETE'S DISPLAY OF HOSTILITY TOWARDS HIS OPPONENT, THE SECRETARIAT, OFFICIALS, THE REFEREE OR THE SPECTATORS BEFORE, DURING OR AFTER THE BOUT.
- ▶ IF A COMPETITOR BITES, PULLS HAIR, HITS OR PRESSES IN THE GROIN OR EYES, OR INTENTIONALLY CAUSES INJURY OF ANY KIND.
- ► IF A COMPETITOR EXPRESSES A DISRESPECTFUL ATTITUDE TOWARDS HIS OPPONENT OR SPECTATORS IN VERBAL FORM OR GESTURES DURING A MATCH OR CELEBRATION OF VICTORY.

MEDICAL TIME

IN THE EVENT OF AN INJURY, THE ATHLETE IS GIVEN TIME TO RECOVER. THE TOTAL TIME FOR ONE ROUND IS 2 MINUTES. IF, AFTER 2 MINUTES, THE LIFTER IS UNABLE TO CONTINUE THE MATCH, THE VICTORY IS AWARDED TO HIS OPPONENT. THE OFFICIAL DOCTOR OF THE TOURNAMENT HAS THE RIGHT NOT TO ALLOW THE CONTINUATION OF THE BOUT IN CASE OF INJURY OF THE ATHLETE.



THE REFEREEING OF THE AIGA CHAMPIONS LEAGUE CHAMPIONSHIP IS CARRIED OUT BY QUALIFIED REFEREES WHO HAVE INTERNATIONAL CLASS "A" CERTIFICATES



- ▶ WEIGH-INS WILL TAKE PLACE ACCORDING TO THE SCHEDULE;
- ► DURING THE WEIGH-IN CEREMONY, THE PARTICIPANT MUST SHOW THE DECLARED WEIGHT WITHIN THE ALLOTTED TIME ACCORDING TO THE SCHEDULE;
- ► A PARTICIPANT WHO DOES NOT MEET THE LIMIT OF THE WEIGHT CATEGORY UP TO 1 KG WILL START EACH ROUND WITH A SCORE OF -4 POINTS;
- ► A PARTICIPANT WHO EXCEEDS THE LIMIT OF THE WEIGHT CATEGORY BY 1 KG OR MORE WILL BE DISQUALIFIED AND WILL NOT BE ABLE TO TAKE PART IN THE COMPETITION:
- ▶ PARTICIPANTS MUST WEIGH THEMSELVES IN SHORTS AND A T-SHIRT/RASHGUARD.
- ► TEAMS MUST ATTEND THE WEIGH-IN CEREMONY IN FULL FORCE (ALONG WITH THE MANAGER) AND WEIGH THEMSELVES IN AT THEIR ALLOTTED TIME.
- ► THE PARTICIPANT MUST HAVE A PASSPORT OR OTHER IDENTITY DOCUMENT WITH HIM/HER.



ATHLETES MUST FOLLOW THE RULES OF THE COMPETITION REGARDING THE DRESS CODE OF INDIVIDUAL REQUIREMENTS. IF THE PARTICIPANT OF THE COMPETITION DOES NOT COMPLY WITH THESE RULES, HE WILL NOT BE ALLOWED TO PARTICIPATE IN THE TOURNAMENT.

ATHLETES DRESSED IN SHORTS, RASHGUARD/T-SHIRT (IT IS NOT ALLOWED TO PERFORM BARE-CHESTED) AND TIGHTS COVERING THE ATHLETE'S HIPS AND KNEES ARE ALLOWED TO COMPETE.

FORM REQUIREMENTS:

RASHGUARD/T-SHIRT: ATHLETES ARE REQUIRED TO WEAR A TIGHT-FITTING T-SHIRT OR A RASHGUARD THAT COVERS THE TORSO, AND THE LENGTH OF THE T-SHIRT MUST BE UP TO SHORTS.

SHORTS:

THE LENGTH OF THE SHORTS SHOULD BE AT LEAST MID-THIGH (NO MORE THAN 10 CM, ABOVE THE KNEE). SHORTS SHOULD NOT BE BELOW THE KNEES. POCKETS ARE ALLOWED, BUT THESE POCKETS MUST BE SEWN AND FREE OF BUTTONS, TIES, PLASTIC OR METAL ZIPPERS.

COMPETITORS ARE REQUIRED TO WEAR ELASTIC TIGHTS THAT FIT THE LEGS (TIGHTS). THE LEOTARD SHOULD BE BELOW THE KNEES. IT IS FORBIDDEN TO USE SHOES, HATS, HAIR CLIPS, JEWELRY, SHELLS (PROTECTIVE EQUIPMENT FOR THE GENITALS) OR OTHER PROTECTIVE EQUIPMENT MADE OF HARD MATERIALS THAT MAY CAUSE INJURY TO THE OPPONENT OR THE COMPETITOR HIMSELF.



IT IS ALLOWED TO WEAR BRACES ON THE KNEE AND ANKLE, PROVIDED THAT THE BRACE DOES NOT HAVE METAL AND/OR PLASTIC ELEMENTS.

EACH TEAM WILL BE REQUIRED TO PROVIDE A PHOTO OF THE COMPETITION EQUIPMENT FOR APPROVAL IN ACCORDANCE WITH THE AIGA RULES. THE ENTIRE TEAM MUST HAVE THE SAME EQUIPMENT.



ONLY ONE COACH CAN BE ON THE COMPETITION GROUND WITH THE ATHLETE. DURING THE BOUT, THE COACH IS WITHIN THE BOUNDARIES OF THE COURT AND CAN PROMPT AND SECOND HIS ATHLETE.

THE COACH MUST BE DRESSED APPROPRIATELY (IN A TRACKSUIT OR OFFICIAL UNIFORM). PERFORMING ATHLETES WEARING SHORTS AND A RASHGUARD TO SECOND ANOTHER ATHLETE ARE NOT ALLOWED ON THE COMPETITION GROUND. A SPECIAL DRESS CODE MAY BE ESTABLISHED WITHIN THE FRAMEWORK OF THE TOURNAMENT.

IF A COACH DEMONSTRATES INAPPROPRIATE BEHAVIOR TOWARDS REFEREES, ORGANIZERS, ATHLETES, SPECTATORS OR ANYONE ELSE, THE REFEREE HAS THE RIGHT TO REMOVE HIM FROM THE REFEREE'S AREA FOR THE REST OF THE FIGHT.

THE ORGANIZERS OR THE HOST PARTY ALSO HAVE THE RIGHT TO PROHIBIT THE PRESENCE OF ANY UNDESIRABLE PERSONS IN THE COMPETITION AREA.
